CXS responsibly abides with the **Entertainment Software Rating Board (ESRB)** and registered users are automatically filtered according to the games that can be accessed for certain age ranges or otherwise, permitted through this consent form (Made possible by **CXS PrePaid MAX™ Technology for automated per-minute charging & cybercafé management and control**). Games are rated by the following:

- **E – Everyone:** have content that may be suitable for persons **ages 6 and older**. Titles in this category may contain minimal violence, some comic mischief and/or mild language.
- **T – Teen:** have content that may be suitable for persons **ages 13 and older**. May contain violent content, mild or strong language and/or suggestive themes.
- **M – Mature:** have content that may be suitable for persons **ages 17 and older**. Titles in this category may contain mature (yet never graphic sexual themes), more intense violence and/or strong language.
